

Our Guest Speakers

Ilora Finlay FRCP, FRCGP, FMedSci, FHEA, FLSW



Professor Ilora Baroness Finlay of Llandaff is an independent Crossbench Peer in the House of Lords, and a Deputy Speaker. She is a member of the House of Lords Special Inquiry Committee on the Integration of Primary and Community Care.

She has pushed legislation on many health issues, securing the Chief Coroner, banning smoking in public places, recently ensuring that the Health and Care Act now includes palliative care as a core NHS service and high-street cosmetic procedures become regulated. She was a Member of the House of Lords Select Committee on the Assisted Dying Bill and chaired the Select Committee of Science and Technology inquiry into Allergy. She co-chairs several All-Party Parliamentary Groups, including Global Health. Her current Private Members' Bill concerns internet safety.

She chairs the Commission on Alcohol Harms; CO Research Trust; co-chairs the Bevan Commission in Wales and was Vice-Chair of NICE's ME/CFS guideline. She established Living & Dying Well, a think-tank around end-of-life issues, and has spoken and written extensively on the subject, including co-authoring the book 'Death by Appointment'. She is currently a member of The Times Commission on Health and Social Care.

At Cardiff University, she established the Palliative Care Diploma/MSc in 1989 and led palliative care service development across Wales, implementing a national strategy that provided 24/7 advice, 7 day specialist palliative care services across Wales and fair funding of services through a funding formula based on estimated needs, which included paediatric and transitional palliative care. She previously held a visiting professorship: the Johanna Bijtel chair, at Groningen University, supporting development of palliative care services and teaching in the region and also in Caen's Baclesse Cancer Centre. She is currently on the International Scientific Expert Committee of the Cicely Saunders Institute, Kings College, London and the Health and Care Research Wales Advisory Board. Chairing the National Mental Capacity Forum for 6 years, she ran rapid-response webinars on mental capacity during Covid.

She holds an Honorary Professorship at Cardiff University, has taught and lectured widely and has over 230 papers in peer-reviewed journals. She was named Welsh Woman of the Year in 1996, Dod's Peer of the Year in 2008, given the Livery Company of Wales' lifetime achievement award 2014, and was a Founding Fellow of the Learned Society of Wales in 2010. She was listed in the 100 most influential Women in Westminster by Politics Home in 2022 and in 2023. She is President of the Chartered Society of Physiotherapy, a past-President of the Royal Society of Medicine, BMA, Medical Women's Federation and the Association for Palliative Medicine, and Vice-President of several charities, including City Hospice, Hospice UK and Marie Curie.



Dr Ann Goldman

Ann is a retired paediatrician. She has been a pioneer in palliative care for children and was the first specialist paediatrician in the field. She established the multidisciplinary Symptom Care Team at Great Ormond Street Hospital in 1986. She has worked in clinical care, research, teaching and the development of palliative care services for children nationally and internationally. She is an editor of the Oxford Textbook of Palliative Care for Children. She is a Trustee at Helen & Douglas House Children's Hospice.

Marisa Mason, CEO, NCEPOD

Marisa joined NCEPOD in 2002 after completing a PhD and post-doctoral research in stroke prevention. She took over as Chief Executive Officer in 2006 and has been part of the many changes and exciting challenges that have faced the organisation over the last 14 years; including the extension of NCEPOD's remit to include mental health, primary care and child health. Marisa has a strong interest in using data efficiently to improve the quality of care provided to patients, while respecting patient and clinician confidentiality.

Alex Ruck Keene KC (Hon)



Alex Ruck Keene KC (Hon) is an experienced barrister, writer and educator. His practice at 39 Essex Chambers in London is focused on mental capacity, mental health and healthcare law. He also writes extensively, editing and contributing to leading textbooks, and is the creator of the website Mental Capacity Law and Policy. He is also a Visiting Professor at King's College London, a Visiting Senior Lecturer at the Institute of Psychiatry, Psychology and Neuroscience, King's College, London and a Research Affiliate at the Essex Autonomy Project, University of Essex. He now spends much of his time on policy matters, including most recently as specialist adviser to the Joint Committee on Human Rights for their 2021-2022 inquiry into human rights in the care setting. He was appointed to the BMA Medical Ethics Committee in August 2023. His contributions to mental capacity and mental health law outside the court room led to him being made an Honorary KC in 2022.

Dr Rachel Clarke

Dr Rachel Clarke is an NHS palliative care doctor and the author of three Sunday Times bestselling non-fiction books about medicine. The latest, Breathtaking, reveals how she and her colleagues confronted the first wave of the Covid-19 in 2020, and has been adapted as a major ITV television series to be broadcast in 2024. Dear Life (2020), depicting her work in an NHS hospice, was shortlisted for the 2020 Costa Biography Award and chosen as a BBC Radio 4 Book of the Week.

Before going to medical school, Rachel was a broadcast journalist. She produced and directed current affairs documentaries focusing on subjects such as Al Qaeda, the Iraq War and the civil war in the Democratic Republic of Congo. She continues to write regularly for the Guardian, Sunday Times, New Statesmen, Lancet and BMJ among others.

Inspired by a visit to Ukraine during the conflict in late 2022, she recently founded a registered charity, Hospice Ukraine, supporting the work of palliative care teams in Ukraine.



APPM Formulary 2024 6th Edition



The new edition of the APPM Formulary is now available to purchase at a special introductory rate of £15 per copy at the conference. The Formulary can also be purchased at the standard price or downloaded for free from the website.

This latest edition represents a substantial revision from the previous version. The entire formulary has been reviewed and updated incorporating recent published literature, specialist advice and feedback from formulary users. Many of the monographs have been extensively rewritten and references have been brought up to date. The formulary has also been completely reformatted, including greater use of tables and with the aim of improving clarity and navigability.

Important changes include:

- Substantially revised or reformatted opioid equivalence tables including new recommended approximate equianalgesic ratios for morphine, diamorphine and oxycodone
- Use of a QR code to link the printed formulary directly to the APPM Website for updates and supplementary information

These changes will be outlined in more detail during the APPM Formulary presentation.
